2. Our terms are Net 30 ; for example, purchases made during the month of March should be paid by April 30<sup>th</sup>.
3. Accounts are considered delinquent if payment has not been received in our office by the last day of the month following purchase.
4. Accounts still delinquent on the last day of the following month shall be placed on a cash only basis for future purchases until the delinquency is paid in full at sole option.
5. Balances due and still unpaid at the end of the month are subject to a service charge of 1 ½% per month (18% per annum), minimum of \$1.00 on the unpaid balance.
6. It is agreed that in case suit is instituted to collect amounts due for materials ordered by or provided to customer, then Ferndale Ready Mix & Gravel, Inc. shall be entitled to an award of reasonable fees and costs.
7. It is agreed that venue for any suit brought under any contract or agreement with customer shall be in Whatcom County, Washington.
8. NSF/returned checks are subject to a \$25.00 handling charge and are not re-deposited. We require that NSF checks be replaced with cash or a cashier's check.
9. Request for copies of statement or invoices should be made promptly so that payment is not delayed. Missing invoices are not a valid reason for late payment.
10. Lack of purchase order or job numbers do not affect the term of our sales.
